Dear Sir

I am very much ashamed to make this open admission of guilt to being a party to a horrible and terrible crime. I have been living with guilt and inner torment since the time the act took place.

I am a catholic and I went to a parish priest in the sacrament of confession of penitence. Father told me inside of the confessional my sin was very grave and that he could not give me absolution for being a party to a very heinous crime. Father said I must make an open admission of guilt to the persons I have offended and to the legal authorities. He said he could not give absolution until it was done. That true contrition could only be had if the admission was made to being a party to the crime.

I [redacted] due hereby confess to being an accessory before, during, and after the fact of the murder of Sweden Prime Minister Palme. I do admit to being after the fact of the murder of Sweden Prime Minister Palme. I do admit to being the contact man between [redacted] who pulled the trigger on Sweden Palme in Stockholm. I provided both the murder weapon and latter money to [redacted] a Swede national, from [redacted].

The money came from [redacted] American oil billionaire. [redacted] made an early arrangement during Ronald Reagan first presidential election for his block of electro votes. [redacted] wanted his man William Casey as CIA director ( I swear by God the truth is Ronald Reagan knew nothing of what [redacted] intended to do. The U.S. Government knew nothing of what [redacted] & Casey intended to do ) [redacted] control Casey and the House ( House is CIA inside the U.S.) The House is divided into 4 regions Southwest SE, NE, NW, and a 5th who heads the 4 regions. The murder of Palme went from the Head of the 4 regions [redacted] to the Southwest part of the House whose boss is [redacted]

My conscience will not let me rest [redacted] has had an innocent secondary suspect arrested in Sweden for the crime hoping he will be convicted and the case closed. [redacted] influence in Sweden is very strong, he owns up to 50% of everything in Sweden. Palme had a bill on his desk which was going to take [redacted] property away from him, and return it to the people of Sweden. Thats what got him murdered.

I swear I didn't know [redacted] was going to do that murder a Prime Minister. I thought it was only small fry. Please forgive me. I cannot go on living with this guilt. I knew [redacted] and his dealings with the CIA years ago when he was in Washington D.C. Please forgive me do not convict that innocent man of it. I am so very sorry
